The Board of Directors of the Chamber of Commerce have established an award in memory of the late Marvin J. Lewis, Esq. As a Past President and **Director, Marvin's efforts were intimately involved in guiding the chamber's** growth and development. We are pleased to grant the Marvin J. Lewis Community Service Award to outstanding members of our community who qualify most highly, both in deed and spirit. Their long-term efforts and involvement have made a significant, positive impact upon life within the Perkiomen Valley.

This year our recipient was Joel W. Eisner, M.D.. An Internal Medicine Physician who has cared for the residents of Phoenixville, Pottstown and the Philadelphia suburbs for nearly 50 years. After growing up in Pottstown, PA, Dr. Eisner earned his undergraduate degree at the University of Pennsylvania and attended Medical School in New York. He then returned to Philadelphia, completing a Residency in Internal Medicine at Temple University. After military service, he settled in Phoenixville in 1969 where he was the first Internal Medicine Physician at Phoenixville Hospital. He single-handedly modernized the Hospital by organizing Emergency Room and Inpatient Care and introduced the new concepts of Intensive and Coronary Care units. Over the years, he served as President of the Medical Staff and Chairman of the Department of Internal Medicine and Family Practice for more than 20 years. In 1970, Dr. Eisner founded Phoenixville Medical Associates, gradually adding Specialists and Primary Care Physicians that exists today as PMA Medical Specialists, LLC. Dr. Eisner remains active as Chairman of the Board of PMA. Other notable achievements include founding of Clinical Care Associates with the University Of Pennsylvania School Of Medicine, serving as Vice Dean of Education. He also helped negotiate the sale of Phoenixville Hospital to the University of Pennsylvania in the 1990s with the offshoot formation of the Phoenixville Community Health Care Foundation. In the 1980s, he and others founded one of the area's first HMOs, Freedom Health Care, which was eventually sold to Aetna.

Above all, Dr. Eisner is a Master Physician. He remains dedicated to Primary and Preventative Care. Not only is he an astute Clinician but has unsurpassed caring and compassion for his patients. He has a wonderful sense of humor but can be tough when needed. Other Physicians seek him out to care for them and their family members. He has mentored countless medical students, patient extenders and young physicians. He has been in medical practice for 6 decades, yet maintains a full schedule including weekend and Emergency Call. The number of patients he has seen and continues to see is legendary. Dr. Eisner is dedicated to quality care and always expresses his feeling of "privilege to be your physician." *PVCC Board of Directors have made a donation on Dr. Eisner's behalf to Phoenixville Area Community Services.*
